We're here to provide our local community with a chance out of the darkness of substance abuse and dependency. And to keep the momentum going.

Serenity House continuously engages in quality improvements to provide innovative and highly effective treatment services that facilitate recovery at its strongest.

Here's a look into the moves we've made this year.

Over **28,000** days of service provided to men and women within our residences. This included group and individual counseling, life skills training, weekly education sessions, peer-led support, and case management.

Over 5,000 comprehensive outpatient counseling services and 1,900 intensive outpatient counseling services were provided to men and women. These included drug and alcohol assessments, DUI evaluations, and risk education classes.

Over **100** individuals from 12 to 19 years of age received Adolescent Counseling and educational services. These continue to reinforce and assist our youth in behavior change and risk reduction.

Weekly family education sessions provided along with expanded family support group activities through Women's Extended Residential Care.


